For more than 20 years, NNRG has worked with landowners in the Pacific Northwest to steward forests for both ecological health and economic viability. We focus on the smaller woodlands owned and managed by private landowners, smaller forest product companies, governmental agencies, and nonprofit organizations.

NNRG strives to promote the highest level of conservation-based forest management. Forest Stewardship Council® (FSC®) certification is one tool we use to provide recognition to forest owners who are careful stewards of their forests.

Supporting Membership is open to any landowner, individual, organization, company, or government entity. It is primarily for individuals and groups who do not wish to receive direct forest management assistance from NNRG, but who would like to support our organization, receive our newsletter and receive special members-only announcements.
